QuestSoft Receives Perfect Satisfaction Rating Among Credit Unions in Latest Customer Survey

Notes about the Survey

The QuestSoft customer satisfaction survey has been conducted after each year's Home Mortgage Disclosure Reporting Act (HMDA) deadline since 2008, using the same methodology each year. The company sends an email survey through Survey Monkey to each person authorized to download the company's HMDA RELIEF or CRA RELIEF software. In 2014, the HMDA deadline fell on Monday, March 3. Therefore the survey was conducted between Tuesday, March 4 and Friday, March 13, 2014. A total of 3,512 surveys were distributed and the company received 520 completed surveys. Of the 520, 93 specifically identified themselves as credit unions and 100 percent of those are reflected here.
